

## **Registration Agreement**

### **Additional terms and conditions for the registration of domain names with the Top-Level-Domains listed in Schedule 1.**

The registration of these domains globally follows the prescribed set of terms and conditions specified by the Internet Corporation for Assigned Names and Numbers (ICANN) and Donuts, Inc. and its subsidiaries as listed in Schedule 1 (together referred to as: "Donuts") being the authoritative registry. These rules are incorporated into the registration agreement as follows:

1. The registrant guarantees that neither the registration of the domain name nor the manner in which it is used infringes the legal rights of any third party or any applicable laws and regulations.
2. The Registrant acknowledges the prohibition of distributing malware, abusively operating botnets, phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engaging in activity contrary to the Donuts Acceptable Use Policy, other Registry Policies, and/or applicable law, and providing (consistent with applicable law and any related procedures) consequences for such activities including suspension of domain names (including without limitation)
3. The registrant shall (within thirty days of demand) indemnify, defend and hold harmless his provider, united-domains AG, the Internet Corporation for Assigned Names and Numbers (ICANN), Donuts and their respective contractors, service providers, and the members, shareholders, directors, managers, each of their respective owners, directors, managers, officers, employees, contractors, service providers and agents of each of them and all other persons involved in the registration process from and against any and all claims, damages, liabilities, costs and expenses, including reasonable legal fees and any other expenses (including on appeal) arising out of or related in any way to the registrant's domain name registration, including, without limitation, the use, registration, extension, renewal, deletion, and/or transfer thereof and/or the violation of any applicable terms or conditions governing the registration or the use of the domain. The registrant shall not enter into any settlement or compromise of any such indemnifiable claim without united-domains AG's prior written consent, which consent shall not be unreasonably withheld, and this entire indemnification obligation shall survive the termination or expiration of the Registration Agreement for any reason.
4. All domains under these conditions are registered by united-domains AG as accredited registrar. Should a domain be registered incorrectly by united-domains AG or any other person involved in the registration process, e.g. not according to the order, registrant hereby irrevocably consents to all necessary measures being taken for the correction of such mistake. Registrant agrees to immediately correct and update the registration information for the Registered Name during registration term for the Registered Name, failure to correct this information shall constitute a breach of this Agreement.
5. For disputes over the rights to domains, a worldwide Uniform Domain Name Dispute Resolution Policy (UDRP) and Uniform Rapid Suspension System (URS) has been developed by ICANN and adopted by all accredited registrars. All domains subject to this agreement are governed by this UDRP and URS. Registrant hereby agrees that all disputes on the rights to such domains, especially arising out of trademarks, names or other intellectual property rights, shall be governed by the UDRP which can be found at [www.icann.org/dndr/udrp/policy.htm](http://www.icann.org/dndr/udrp/policy.htm) and URS which can be found at [newgtlds.icann.org/en/applicants/urs](http://newgtlds.icann.org/en/applicants/urs) and comply with the requirements set forth by Donuts for domains registered during the Sunrise Period, including the mandatory Sunrise Dispute Resolution Policy.

ICANN reserves the right to modify the UDRP and URS at any time. united-domains AG as accredited registrar shall implement any such revision speedily and these will become binding upon the registrant. Any revised version will be posted at: [www.icann.org/](http://www.icann.org/)

6. According to the technical standards and procedures of the internet the registrant consents to the use, copying, distribution, publication, modification, and other processing of Registrant's Personal Data, including personal data by Donuts and its designees and agents. This data is stored within the contractual commitments and transferred to other persons inside and outside Germany involved in the registration process, including specifically (but not limited to) the USA. The registrant consents for each registration to the collection and use of such Registrant's Personal Data according to Donut's privacy policy located at the Registry Website under "Policies" (the "Privacy Policy").
7. Registrant warrants that notification equivalent to that described in Section 6 above has been given to any third-party individuals whose Personal Data are supplied to united-domains AG by the registrant, and that the registrant has obtained the consent equivalent to that referred to in Section 6, last paragraph, of any such third-party individuals.
8. Registrant acknowledges that Donuts will have no liability of any kind for any loss or liability resulting from the proceedings and processes relating to the Sunrise Period or the Land Rush Period, including, without limitation: (a) the ability or inability of a registrant to obtain a Registered Name during these periods, and (b) the results of any dispute over a Sunrise Registration.
9. united-domains AG and Donuts expressly reserve the right to deny, reject, revoke, suspend, delete, cancel or transfer any registration or transaction or place any domain name(s) or other transactions on registry lock, hold or similar status, that it deems necessary, in its discretion; to protect the integrity and stability of the registry; to comply with any applicable laws, government rules or requirements, requests of law enforcement, in compliance with any dispute resolution process; to comply with the terms of the Registry Agreement; if a Registrant fails to keep registration contact information accurate and current; the domain name use violates Registry Policies generally (e.g., Acceptable Use Policy) or a third party's rights or acceptable use policies, including but not limited to the infringement of any copyright or trademark; to avoid any liability, civil or criminal, on the part of Donuts, as well as its affiliates, subsidiaries, officers, directors, and employees; per the terms of the Registration Agreement; or to correct mistakes made by Donuts or united-domains AG in connection with a domain name registration.
10. Donuts, Inc. has appointed subsidiaries to act as Registry Operators for the respective Top-Level-Domain as listed in Schedule 1.
11. The Registrant acknowledges having read and understood and agrees to be bound by the terms and conditions of the following documents, as they may be amended from time to time, which are hereby incorporated and made an integral part of this Agreement:

## **Additional requirements for the registration of domain names with the Top-Level-Domains listed in Schedule 2.**

### Additional requirements for Regulated TLDs:

1. The Registrant must comply with all applicable laws, including those that relate to privacy, data collection, consumer protection (including in relation to misleading and deceptive conduct), fair lending, debt collection, organic farming, disclosure data, and financial disclosures;
2. The Registrant will receive notification from united-domains AG at the time of registration of the requirements to comply with all applicable laws; and
3. Registrants who collect and maintain sensitive health and financial data must implement reasonable and appropriate security measures commensurate with the offering of those services, as defined by applicable law.

### Additional requirements for the highly-Regulated TLDs:

1. The provisions listed in 1-3 of the Safeguards to Regulated TLDs listed above.
2. Registrars must provide administrative contact information, which must be kept up-to-date, for the notification of complaints or reports of registration abuse, as well as the contact details of the relevant regulatory, or industry self-regulatory, bodies in their main place of business; Represent that Registrant possesses any necessary authorizations, charters, licenses and/or related credentials for participation in the sector associated with the TLD

### Additional requirements for Inherent Governmental Functions Donut TLDs:

1. Registrants must comply with all applicable laws, including those that relate to privacy, data collection, consumer protection (including in relation to misleading and deceptive conduct), fair lending, debt collection, organic farming, disclosure of data, and financial disclosures.
2. Registrants must receive notification from Registrar at the time of registration of the requirements to comply with all applicable laws;
3. Registrants who collect and maintain sensitive health and financial data must to implement reasonable and appropriate security measures commensurate with the offering of those services, as defined by applicable law;
4. Registrant must provide administrative contact information, which must be kept up-to-date, for the notification of complaints or reports of registration abuse, as well as the contact details of the relevant regulatory, or industry self-regulatory, bodies in their main place of business;
5. Registrants must represent that they possess any necessary authorizations, charters, licenses and/or related credentials for participation in the sector associated with the TLD string;

6. Registrants must report any material changes to the validity of the Registrants' authorizations, charters, licenses and/or other related credentials for participation in the sector associated with the TLD string in order to ensure the continue to conform to appropriate regulations and licensing requirements and generally conduct Registrant's activities in the interests of the consumers they serve; and
  7. Registrant will take reasonable steps to avoid misrepresenting or falsely implying that the Registrant or its business is affiliated with, sponsored or endorsed by one or more country's or government's military forces, if such affiliation, sponsorship or endorsement does not exist.

### **Additional requirements for .ARCHI**

Registrations in .ARCHI are meant for all verifiable participants in the architecture scene. Registrants of .ARCHI domains should acknowledge prior to Registration that they meet at least one of the following criteria:

1. Architect member of the International Union of Architects ("UIA"); or
  2. Architecture firm that employs one or more architects members of the UIA; or
  3. Company or associations that employs one or more architects members of the UIA; or
  4. Being included in a list of architecture schools, museums, professional press/media, defined by the . ARCHI Policy Advisory Committee in collaboration with UIA and its member associations.

### **Additional requirements for .TRAVEL**

Registrations in .TRAVEL are meant for all people or businesses engaged in all things travel related. Registrants of .TRAVEL domains should acknowledge prior to Registration that they are engaged in or plan to engage in activities related to travel.
